**Explanation of Responses:**

1. On January 4, 2019, the reporting person was granted performance-based restricted stock units (PSUs) of the Issuer, which vest upon the satisfaction of certain performance criteria. The remaining ordinary shares subject to the PSUs vest in equal annual installments on January 21, 2021 and January 21, 2022.

2. Each PSU represents a contingent right to receive one ordinary share of the Issuer.
